A) Annual General Meeting:

This is to inform that the 12th Annual General Meeting ("AGM") of members of the Company will be held on **Monday, 26 September 2022** at 3:30 P.M. (1ST) through Video Conferencing ("VC") / Other Audio Visual Means ("OAVM"), in accordance with the applicable circulars issued by the Ministry of Corporate Affairs and the Securities and Exchange Board of India.

B) Closure of Register of Members and Share Transfer Books:

Pursuant to the provisions of Section 91 of the Companies Act, 2013 and the rules made thereunder and Regulation 42 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, Register of Members and Share Transfer Books of the Company shall remain closed from Friday, 16 September 2022 to Friday, 23 September 2022 (both days inclusive) for the purpose of determining the names of eligible shareholders for payment of final dividend of Rs. 2.50 per equity share of Re. 1 each (after deduction of tax at source) subject to approval of shareholders.

Dividend upon its declaration at the AGM, will be paid by Friday, 7 October 2022 to the following:

- I. Beneficial Owners in respect of shares held in dematerialized form as per the data as may be made available with National Securities Depository Limited ("NSDL") and the Central Depository Services (India) Limited ("CDSL"), as at the end of day on Thursday, 15 September 2022;
- II. Members in respect of shares held in physical form after giving effect to valid transmission or transposition requests lodged with the Company as of the close of business hours on Thursday, 15 September 2022.

C) E-voting

The Company has availed the services of NSDL for providing e-voting services before and during the AGM. The remote e-voting period shall commences on Friday,23 September 2022 (9:00 a.m. IST) and ends on Sunday, 25 September 2022 (5:00 p.m. IST). During this period, Members holding shares either in physical form or in

Those members, who will be present in the AGM through VC / OAVM facility and would not cast their vote on the resolutions through remote e-voting and are otherwise not barred from doing so, shall be eligible to vote through e-voting system during the AGM ("Venue Voting").
