Pursuant to Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("**Listing Regulations**"), we wish to inform you that Board of Directors of RHI Magnesita India Limited ("**the Company**") at its meeting held today i.e. 14 August 2026, has inter alia, considered and approved the following:

1. Resignation of Statutory Auditors

The Board took note of the resignation of M/s Price Waterhouse Chartered Accountants LLP (Firm Registration No. 012754N/ N500016) as the Statutory Auditor of the Company and RHI Magnesita India Refractories Limited ("**RHIMIRL**"), material wholly owned subsidiary with Immediate effect, pursuant to their respective resignation letters dated 14 August 2026, to align the Statutory Auditor with the Ultimate Holding Company i.e. RHI Magnesita N.V.

Copy of the resignation letters received from the aforesaid auditor, together with the disclosures required under Regulation 30 read with Schedule III of the Listing Regulations and SEBI Master Circular No. HO/49/14/14(7)2025-CFD-POD2/I/3762/2026 dated 30 January 2026, are enclosed as **Appendix A**.

The Board of Directors of respective Companies further noted the confirmation provided by the outgoing Statutory Auditors that there are no concerns, issues, or reasons for resignation other than those stated in the resignation letters. The Board also placed on its record appreciation for the professional services, guidance, and support rendered by M/s Price Waterhouse Chartered Accountants LLP during its tenure as the Statutory Auditor of the Company and RHIMIRL.

2. Appointment of New Statutory Auditors

Based on the recommendation of Audit Committee, the Board of Directors of the Company and RHIMIRL have approved the appointment of M/s. B S R & Co. LLP, Chartered Accountants (Firm Registration No.101248W/ W-100022) as the Statutory Auditor of the Companies to fill the casual vacancy arising from the resignation of M/s Price Waterhouse Chartered Accountants LLP, subject to the approval of the members, wherever applicable.

Further, the Board of Directors of the Company has recommended the appointment of M/s B S R & Co. LLP as the Statutory Auditor of the Company for a term of five (5) consecutive years, commencing from the conclusion of the 16th Annual General Meeting to be held in Calander year 2026 and continuing until the conclusion of the 21st Annual General Meeting to be held in Calander year 2031, subject to shareholders' approval.

Similarly, the Board of Directors of RHIMIRL has recommended the appointment of M/s B S R & Co. LLP as the Statutory Auditor of RHIMIRL for a term of five (5) consecutive years, commencing from the conclusion of the 8th Annual General Meeting to be held in Calander year 2026 and continuing until the conclusion of the 13th Annual General Meeting to be held in Calander year 2031.
